RESOLUTION FOR THE ADOPTION OF FEES FOR SERVICE

A Resolution to provide a fee structure for the review and inspection of properties covered by the International Fire Code of the City of Lakeway, the Village of Bee Cave and, the Travis County Emergency Services District No. 6 Fire Code Ordinance 2005-01. This Resolution also provides for fees for administrative services.

Administrative Fees:

Reports for Fire, EMS or any Incident Response	\$5.00 each
Copies of records made by District	\$0.10 per page or as specified per Open Records Act Administrative Code Title 1, Part 3, Chapter 70, Rule 70.10
Returned checks	\$25.00

Plan Review Fees:

Site and Subdivision plans	\$300/section
Building plans – new shell buildings	\$200 + 0.10 per sq ft of interior build out
Building plan – new tenant space	\$200 + \$0.10 per sq ft
Building plan – remodel of existing tenant space	\$150
Automatic Sprinkler Systems (New):	
Less than 6000 sq ft	\$500
6001-12,000 sq ft	\$600
Greater than 12,000 sq ft	\$600 + \$0.01 per sq ft over 12,000sf (maximum fee \$800)
Automatic Sprinkler Systems remodel over 20 heads	\$100
Standpipe Systems	\$300
Fire Alarm Systems	\$200 for 200 or fewer devices >200 devices \$260 + \$0.50 per device over 200 devices

Re-inspections of Fire Final and Fire Protections System	\$150
Tests (applied on 3rd and subsequent visits)	
Hydrant flow test	\$100
Kitchen Vent hood suppression system	\$50
Alternative fire suppression systems (spray booths, Dry/Wet Chemical, etc.)	\$100
Commercial Propane Installations	\$250

Fireworks stands	\$25
Home foster/adoption	\$15
Daycare annual inspection	\$50 <25 children \$100 >25 children
Health care/Assisted living	\$45 + \$15 per additional building
Hospitals/Licensed clinics	\$100
Permits:	
Hazardous Materials	\$250
Fireworks shows	\$100
Control Burn	\$20
TABC Alcohol License Inspection	\$50
Mass Gatherings Permit (5000 persons or more)	\$200 + \$75 per hour or portion of hour for personnel on site during event and a reasonable charge for use of equipment as determined by the Fire Chief taking into consideration the direct costs to the District in providing the equipment and in reallocating resources as required
Fire Watch	\$75 per hour or portion of hour + cost of apparatus during watch

NOW THEREFORE BE IT RESOLVED THAT:

The members of the Board of Commissioners do hereby approve and adopt Resolution 2007-04 establishing fees for service as specified.

PASSED AND APPROVED at a meeting held on May 24, 2007 at which a quorum of the members of the Board of Commissioners were present.

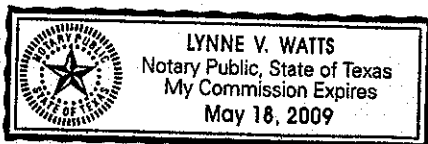
